SCOPE

G-Com UV+ mechanically fixed cladding system for external wall claddings for uses subject to reaction to fire regulations with classes B and C.

- ETA 23/0538, Product family A:
The HPL cladding elements are mechanically fastened to the subframe through visible punctual fixings.
- ETA 23/0530, Product family B:
The cladding elements are mechanically fastened to the subframe by a special anchor placed in a drilled hole or in an undercut hole and anchored by mechanical interlock.

The cladding element alone is provided by the manufacturer.
